Rules for the Tribunal of Record

- No fiction of law may be seen, nor heard, unless presented by the actual and verified owner, whom shall only enter with, and under, his full, personal liability and complete transparency;
- All real-men Living Souls shall present his own side of the matter, unless upon a showing of mental or physical incapacity; if so accepted by the Tribunal of Record that there be a mental or physical incapacity they shall authorize a friend or family member to present the same;
- Both the Proponent and Respondent may have a next friend present to assist in the presentation and questioning;
- Each Signatory of the Tribunal of Record shall at all times and all places discharge his duty and responsibility with and under full liability and complete transparency;
- A decision must be unanimous; if not the Respondent is declared the victor and may be awarded just compensation for his time and expenses according to what is Just and Honorable;
- Sixty (60) days from the service of a sworn complaint upon the Respondent the proceedings shall commence, with later notice of time and place to be effectuated as soon as those can be ascertained with exactness;
- The proceedings, at minimum, shall have an audio recording of the same;
- A Signatory shall be designated to maintain and secure

a record of all filings, recordings and other tangible items of the Tribunal of Record;

- The Signatories of a local Tribunal of Record may authorize a real-man Living Soul, under contract, to effectuate any writs, decrees, actions, orders, judgments, et cetera;
- The Oath that shall be taken and subscribed by any and all Signatories before taking a seat on the Tribunal of Record is as follows, to wit:

"I, _____, do hereby affirm that I, under full liability and complete transparency, will adhere to, and apply, the time-tested truths of maxims of law and equity, natural law, Laws of the Creator, Laws of Creation and moral justice in all matters before myself, that I harbor no ill intent nor prejudice towards either party, and that I take this obligation freely without any hidden purpose or mental evasion."

Procedures up to and for the Duration of Proceedings

- Proponent, who shall be the actual injured party, shall file the sworn or affirmed complaint, including all evidence he may wish to have heard and seen, with the Record Keeper of the Local Tribunal of Record;
- The Record Keeper shall immediately set the date, time and place of trial by Order and give the same to the Proponent to serve upon the Respondent, including the true, accurate and complete copy of the complaint with all evidence to support it;
- The Respondent shall have thirty (30) days to review

- and form his answer, sworn or affirmed, including all evidence he may wish to have seen and heard; The Respondent shall serve upon the Proponent and Tribunal of Record a true, accurate and complete copy of the same;
- The Record Keeper shall by random select twelve (12) disinterested Signatories to form the Tribunal of Record that shall decide all matters at hand;
 - The Proponent shall, at the start of the proceeding, present his evidence and witnesses;
 - The Respondent may, as each piece of evidence or witness is presented, question the same;
 - After the questioning, any Signatory sitting on the Tribunal of Record may question the same;
 - The Respondent shall then proceed to present his evidence and witnesses;
 - The Proponent may, as each piece of evidence or witness is presented, question the same;
 - After the questioning, any Signatory sitting on the Tribunal of Record may question the same;
 - After both parties have presented their side, the Signatories sitting on the Tribunal of Record shall meet privately to discuss the present matter;
 - One signatory shall be appointed as Chief whom shall speak on behalf of all;
 - A unanimous decision is required for guilty, otherwise it shall be innocent;
 - If the decision is guilty the pains and penalties shall be discussed and decided;
 - Once a discussion has taken place and decision made

- The Chief shall announce the decision;
- The Security for the Tribunal of Record shall effectuate and/or enforce the same, if necessary;
 - The Chief shall act as the collector of any monetary damages so ordered, and shall immediately turn the same over to the proper party, or heirs;
